#### Old Business:

Ben Stovall is being covered by USA Dance in the lawsuit brought by Sue Johnson. Response has been postponed 30 days as a result of a motion filed by USA Dance and will give Ben more time to gather information. It is possible that those who gave statements will be contacted again.

The other instructors are aware of what has happened and Jorja has requested a statement from USA Dance that would show she is covered should something happen. The contact at National has pushed back and said that in the future, instructors may be required to be members. As of now, we're not pushing the issue with our instructors since National is not aware of how we really operate.

We have not heard back more about the classes at the library this summer.

It was proposed that we send \$200 to National for scholarships for competitors. By email vote, the motion was approved.

It was proposed that we spend an extra \$50 at the April dance to have the car moved inside. By both email vote and an in-person vote at the April meeting, the motion was approved.
