## **Webmaster Update:**

#### **Old Business:**

By email vote, it was decided to not host our charity ball this year. The prices for the October dance will be \$12 for members and \$15 for non-members.

#### **New Business:**

A snowball was brought up as a possible way to get more women dancing. It would replace one of the mixers. The idea was tabled until after the October dance.

Nastasya proposed the changes to the bylaws based on the changes made by National:

- The restriction on the maximum number of board members. We still have a hard minimum of seven.
- Quorum has been changed from two thirds of the board and two officers to a simple majority of board members
- All references to ballroom specifically were removed to reflect the changes in the national bylaws.
- Updated election policies re: campaigning and advertising candidates.

The motion was seconded and approved.
